

## **COMMENT TODAY ON NEW GMO FOOD LABELS RULE**

# **DEADLINE JULY 3**

Remember the **DARK Act** (Deny Americans the Right to Know Act) Congress passed in 2016? *The government calls it the "Safe and Affordable Food Act."* The USDA just released the rules for how it will implement the Law.

As opposed to a well-defined Rule, it is further confusing the issue by proposing a range of alternatives – leaving uncertainty about crucial issues. See resources below for deeper analyses. Read the full <u>RULE HERE</u>.

#### Check out some of the USDA's "Proposals"

- ➤ Change the familiar terms GMO or GE to unfamiliar wording: Bioengineered or BE.
- ➤ Allow for misleading symbols on the packaging including QR codes (requires a smartphone and data access) or smiley-faces.
- Exempt highly refined/processed foods that were made from GMO products.
- Exempt newer forms of Genetic Engineering such as CRISPR, and SynBio.
- ➤ Allow higher GMO threshold levels (5% -10%) than is common practice worldwide (0.9%).





### TELL THE USDA HOW YOU WANT YOUR GMO FOODS LABELED

### **Below are Talking Points for your comments:**

- Use commonly known terms for Genetically Engineered foods, such as GMO or GE. Do not create a new term: Bioengineered. It is confusing.
- ➤ Use clear, on-package labeling. Reject QR codes or text messages. Use neutral graphic symbols not smiley faces.
- Include new genetic engineering technologies, such as CRISPR and Synbio in labeling requirements.
- ➤ Use the same contamination threshold used through the world = 0.9% GE material of the weight of the specific ingredient.
- Impose penalties for non-compliance.
- > Disclosure NOW do not delay until 2022. 64 other countries have been labeling GMOs for years.
